Turn left out of elevators, go through a set of double steel doors and then a set of double wood doors. You'll see the receptionist desk directly in front of you, across the atrium lobby. Bobbie and Lani will be waiting to meet you. If you do not park in the deck and choose to come in the front doors of the building on S. Main Street, please take the regular elevators to R&A's lobby entrance on the 4th floor.
