## **Directions to FASB (Contact: Miriam Solomon, 203-847-0700)**

**From the south (New York City and vicinity),** travel north on the Hutchinson River Parkway. This parkway becomes the Merritt Parkway (Connecticut Route 15) at the Connecticut state line. Take exit 40B and bear right onto Main Avenue. 401 Merritt 7 is on the left, one-quarter mile north of the Parkway. Driving time from New York City is approximately one hour.

**From the north (Hartford, New Haven),** travel south on the Merritt Parkway. Take exit 40B and at the traffic light turn right onto Main Avenue. 401 Merritt 7 is on the left, one-quarter mile north of the Parkway.

**From Interstate 95,** take exit 15 (Route 7 to Danbury). At the end of the connector, turn right onto Grist Mill Road. At the second traffic light, turn right onto Main Avenue and continue to the third traffic light. 401 Merritt 7 is on the right.

**After arrival,** use the callbox to inform Security that you're attending a meeting at FASB and they will let you into the parking area. Parking is available on the first underground level (P1) of the garage in spaces designated "FASB—GASB Visitor". Please sign in at the Guard's Desk on the Plaza Level, and proceed to the 5<sup>th</sup> floor. There will be signs directing you to the Board Dining Room.
